

# Hornbuckle Pool Rules

The rules listed below are for the protection and benefit of all residents in good standing (i.e. dues paid). Parents are requested to instruct their children in observance of all rules. Parents are solely responsible for the actions of their children. **Failure to comply may result in a suspension of privileges.** All persons using the pool or pool area do so at their own risk and responsibility. Hornbuckle Homeowners Association, Inc. assumes no risk for any accident or injury in connection with such use.

## Hours for the pool and restrooms (the clubhouse is only open for social events):

**7am – 9pm**

1. **Use of the pool is for Hornbuckle homeowners. A homeowner must accompany guests in the pool area.**
2. Members and their guests are required to wear swimsuits while swimming. Cut-off pants, jeans or other street clothes are not permitted.
3. Spitting, spouting water, blowing the nose, or discharging bodily wastes in the pool is strictly prohibited. **In the event feces are found in the pool or the kiddie pool, both pools will immediately be closed for a 24-hour period for decontamination by order of the health department. Please contact the pool maintenance company (number posted near the phone.)**
4. Running, rough play, or excessive noise is forbidden in the pool area, clubhouse, porches, or restroom.
5. Snacks inside the pool area will be permitted as long as everyone deposits all trash in trashcans. **No glass of any kind is permitted in the pool area.**
6. A designated smoking area is located on the left side of the pool opposite the kiddie pool.
7. Dogs and other animals are not allowed in the pool enclosure.
8. **Diving off the side of the pool, flipping off the pool deck and jumping off chairs is prohibited.**
9. Small children will have the priority for use of the kiddie pool. Older children should allow the smaller children use of this pool.
10. An assigned adult (over 18 years old) must accompany all children under the age of 14 in the pool area. There should be no assumption that other adults in the pool area will be responsible for your child under 14 years of age without prior arrangements.
11. Safety equipment is to be used only for emergencies.
12. Hornbuckle Homeowners Association, Inc. will not be responsible for the loss of personal property.
13. **Any damage to the property will be charged to the responsible party.**
14. No one is allowed in the pool equipment room except pool officials.
15. Please dry off with a towel before using the restroom located in the clubhouse. Parents, please assist little children with restroom needs in order to maintain sanitary conditions of the restroom.
16. For health and safety purposes, children should not wear disposable diapers in the pool. Infants and children who are not completely potty-trained must wear swim diapers to contain any “accidents” from contaminating the pools.
17. **Bikes, skateboards, scooters, and rollerblades are not allowed in the pool area.**
18. **Use of the pool by anyone after hours is prohibited. The proper authorities will be notified in the event this occurs.**
19. **Climbing the fence is prohibited. Anyone caught doing so will forfeit their pool privileges for the rest of the season.**
20. For insurance purposes, the gate must be kept closed at all times. Please be sure to shut the gate behind you. Under no circumstances open the gate for anyone without a pass!
21. When using the pool, you must have your pool pass in your possession and be prepared to present it if requested. An extra pass (limit 2 per family) or replacement passes are available for a \$25 fee.

**Please report any misuse of the pool area or damage to the furniture to a Board Member.**
